Align your business with The Foundation for Geauga Parks (FGP), Geauga County's leading nature-focused philanthropic organization. The FGP is a 501 (c)3 nonprofit organization established in 1990. Its mission is to fund community engagement with nature through education, preservation, conservation, and appreciation of the unique natural character of Geauga County. We raise funds to preserve and conserve Geauga County green spaces and to support nature education initiatives.

AUDIENCE: Our donors are civic-minded nature-lovers, conservationists, and outdoor enthusiasts. They represent over 2,000 households in Geauga and surrounding counties. 33% of FGP supporters reside in one of the top 15 wealthiest zip codes in Ohio; 45% of our supporters have household income greater than \$100,000/year.

MARKETING: FGP reaches audiences through print literature, signage, press releases, emails, website, Facebook, Instagram, and community outreach activities.

- We distribute monthly press releases to 32 media outlets serving northeast Ohio.
- We post up to five times each week, reaching a growing number of followers (currently more than 1,100 across platforms).
- We have an active email list of 1,200 households and typically send up to six emails each month.
- Our average website traffic is more than 1,200 pageviews per month.
- We not only reach hundreds of individuals through our annual fundraising event and monthly gatherings, but have an active presence at a variety of community events throughout the year.
